ADMINISTRATIVE ORDER  
NO. 2001-29

WHEREAS, Rule 58(e), Arizona Rules of Civil Procedure, requires that the Clerk of the Superior Court mail copies of all minute entries to all parties; and

WHEREAS, it is in the best interest of the Court, attorneys, and parties that the actions and orders of the court recorded in minute entries be disseminated in the most efficient and effective manner possible; and pursuant to Rule 124(d), Rules of Supreme Court;


IT IS ORDERED:

(1) The Clerk of the Superior Court, Mohave County, law firms, sole practitioners, parties representing themselves (pro se), or other county agencies may enter into agreements that the Clerk of the Superior Court, Mohave County, may send minute entries electronically to that particular law firm, sole practitioner, pro se or other county agency. This Agreement shall be in effect unless either party to the Agreement notifies the other, in writing, that paper copies of minute entries will again be generated and mailed. The Agreement shall be in a form similar to the form attached hereto.

(2) If the parties or the Clerk of Superior Court, Mohave County, enter into an Agreement for electronic distribution of minute entries, then e-mail shall be sufficient to comply with Rule 58(e) requirements.

(3) This Order shall remain in effect until further Order of this Court.
